Subject of the contract:

The subject of this tender is:

- Provision of chemicals as indicated in the technical information in the point 2 of these information;

Deadline for submission of the tenders:

The deadline for submission of tenders is **08/01/2025 at 13:00 hours¹**. Any tender received after this deadline will be automatically rejected.

- The Contracting Authority is obliged to provide answer to all questions received no later than 3 days before the deadline communicated simultaneously in writing to all tenderers.

Currency

Tenders must be presented in **RSD with VAT included**.

Note:

In accordance with IPA implementing regulation, for all partners VAT can be an eligible expenditure. The Contracting Authority will pay the unit prices, as stated in the Financial Offer, and will pay the VAT if the VAT is eligible and is clearly identified on the invoices. For this contract VAT is eligible cost.

¹ The tenderer should have minimum 7 days for supply contract from the date of launching of the procurement procedure for preparation of the offer (excluding the day of publishing and the date of submission deadline).



In case when the offers are submitted in National currency, the exchange rate to be used for checking financial compliance with available budget (during financial evaluation), shall be InforEuro exchange rate for the month when the tender is launched

Award criteria:

The sole award criterion will be the price. The contract will be awarded to the lowest compliant tender.

In case that one offer is received, the Contracting Authority shall check whether the offer is administratively and technically compliant with the requirements set by this tender documentation and financial offer is within the available budget.

Variant solutions will not be taken into consideration.

Award notification

The successful tenderer will be informed of the results of the evaluation procedure in written form.

Address and meanings for submission of the tenders:

The tenderers will submit their tenders using the **standard submission form available in the “Part B: Format of offer to be provided by the tenderer” of the tender dossier**. The tender will be submitted in **1 original**. An offer may be also submitted via e-mail. Any tenders not using the prescribed form may be rejected by the contracting authority.

In addition to the offer the tenderer is required to provide the following supporting documentation:

- Copy of legal registration
- 1 reference (copy of Contract, Invoice of Confirmation of reference) with min. value of the financial offer in last 3 years from the date of deadline for tender submission

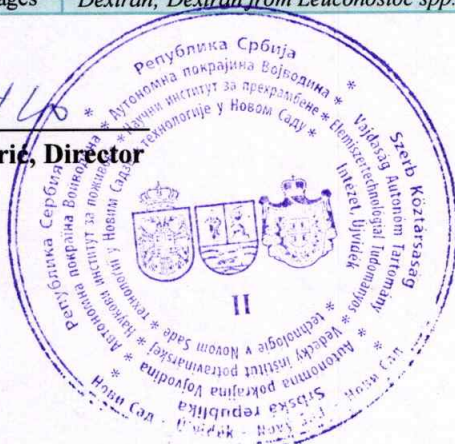
