Subject of the contract:

The subject of this tender is:

- Provision of lab. equipment (Microwave synthesis reactor, Reaction vial for microwave synthesis reactor and Portable density meter) as indicated in the technical information in the point 2 of these information;

Deadline for submission of the tenders:

The deadline for submission of tenders is 11/12/2025 at 13:00 hours¹. Any tender received after this deadline will be automatically rejected.

- The Contracting Authority is obliged to provide answer to all questions received no later than 3 days before the deadline communicated simultaneously in writing to all tenderers.

Currency

Tenders must be presented in RSD with VAT included.

Note:

In accordance with IPA implementing regulation, for all partners VAT can be an eligible expenditure. The Contracting Authority will pay the unit prices, as stated in the Financial Offer, and will pay the VAT if the VAT is eligible and is clearly identified on the invoices. For this contract VAT is eligible cost.
